

MINUTES OF THE REGULAR CITY OF CRESCENT COUNCIL MEETING August 6<sup>th</sup>, 2018. THE CRESCENT CITY COUNCIL met in regular session in the Crescent Community Hall at 7:01pm pursuant to the law. Mayor Brian Shea called the meeting to order. The following council members were present: Hildreth, Anderson, Jacobsen, Powers and Adams.

MOTION BY ANDERSON, seconded by Powers to accept consent agenda. Hildreth, Anderson, Jacobsen, Powers and Adams, all ayes. Motion carried.

ANDERSON addressed the council regarding signage around town/complaints. Discussion over need for stop sign at bottom of Crescent Dr. at Valley, "No Parking" sign in front of Ron Olson's at turn on Valley Drive. "No Parking" sign on edge of parking lot line at OLH & E. Welch. Need to survey for exact lot line. Discussion over 3 way stop at intersection of OLH & E. Welch. Tabled until next month.

MOTION BY HILDRETH, seconded by Powers to proceed with survey. All ayes, motion carried.

MOTION BY POWERS, seconded by Anderson to approve stop sign at Crescent Dr. All ayes, motion carried.

BETTY STRUTHERS addressed council over concerns of recycling center location. Council will look at altering entrance gate for safety. Checking other lots in town for potential relocation.

POOL USE REQUEST for scuba lessons by private instructor. Discussion over safety & maintenance concerns.

MOTION BY HILDRETH, seconded by Anderson to deny request. All ayes, motion carried.

DISCUSSION/UPDATE of road maintenance. Ground quartzite and seal coating used to prevent further wear on streets.

DISCUSSION of options for ditch next to school/Nordstrom property.

DISCUSSION of sidewalk maintenance in Golden Hills. City is not liable to repair/replace sidewalks on personal properties. Plumber has been hired to scope sewer drain.

UPDATE on Golden Hills phase 2, TIF update/agreement.

CRESCENT DAYS parade permit. MOTION BY POWERS, seconded by Hildreth to approve. All ayes, motion carried.

GRANT APPLICATIONS for TSIP, ICAP. MOTION BY POWERS, seconded by Anderson to apply. All ayes, motion carried.

LIBRARY AGREEMENT/ discussion tabled.

LITTLE FREE LIBRARY/ update: citizens volunteered to maintain. Council is giving 30 days to keep out of disrepair or they will be removed.

DONATIONS recognized from Thams Agency and Janice Summy through PCCF.

MOTION BY HILDRETH, seconded by Jacobsen to approve clerk to obtain notary. Charge will be \$5. All ayes, motion carried.

MINDY HIVELY/PARK BOARD Donations to support Music in the Park. Memorial benches have been delivered; \$475 for each with engraving. Donations left over from concessions were donated to Crescent Food Pantry.

Concession building at ball park okayed for use during Crescent Days,
