GALEN BARRETT/FIRE DEPT reported that 2014 ended with 277 calls. CVFD has had no injuries/deaths in his time as chief.

CRAIG PETERSON/MAINTENANCE reported he had cold patched prior to snow. He has been plowing so will check these potholes when roads are clear. Annual maintenance to 1561 (engine), John Deere tractor, and dump truck has all been done. Installed new faucet in kitchen. DURING SNOW REMOVAL, PLEASE PARK YOUR VEHICLES OFF STREET. If this is done, he will be able to do a better job on the roads. Also, do NOT THROW snow from your driveway after he had plowed. This just turns to ice.
