

MINUTES OF THE REGULAR CITY OF CRESCENT COUNCIL MEETING May 5, 2014 THE CRESCENT CITY COUNCIL met in regular session in the Crescent Community Hall at 7:00pm pursuant to the law. Mayor Brian Shea called the meeting to order. The following Council members were present: Morgan, Jacobsen, and Anderson. Hildreth, Clark, absent.

MOTION BY ANDERSON, seconded by Jacobsen to accept consent agenda. Anderson, Jacobsen, Morgan, all ayes. Motion carried.

LOREN KNAUSS/CRIME & SAFETY. Loren addressed council regarding getting some community involvement in a committee to study crime & safety issues county wide. There will be an initial meeting at Treynor Comm. Center on May 29<sup>th</sup> @ 6:30 pm. He would like to see some city officials get involved.

RESOLUTION 050514/Approving Bond purchase agreement/loan agreement for sewer revenue notes for \$805,000. For sewer re-financing and sewer improvement. MOTION BY ANDERSON, seconded by Morgan to approve resolution 050514. Anderson, Jacobsen, Morgan, all ayes. Motion carried.

RESOLUTION 050514-1/Approving Bond purchase agreement/loan agreement & providing \$420,000. GO bonds Sewer improvement and re-financing. MOTION BY JACOBSEN, seconded by Anderson to approve resolution 050514-1. Anderson, Jacobsen, Morgan, all ayes. Motion carried.

RESOLUTION 050514-2/Approve amending 2014 Budget. MOTION BY ANDERSON, seconded by Jacobsen to approve amendment. Anderson, Jacobsen, Morgan, all ayes. Motion carried.

HENRY'S DINER LIQUOR license submitted for approval. MOTION BY JACOBSEN, seconded by Anderson to approve license. Anderson, Jacobsen, Morgan, all ayes. Motion carried.

POTT. CNTY. SHERIFF CONTRACT tabled due to no quorum as Morgan needed to abstain.

ORDINANCE 4-14 PEDDLERS PERMIT 3 reading. MOTION BY MORGAN, seconded by Jacobsen to approve 3<sup>rd</sup> reading. Anderson, Jacobsen, Morgan, all ayes. Motion carried.

KRISTA SMITH/PARK DIRECTOR reported that there are 3 teams. Uniforms for the teams were supplied. Jeri Hatcher is still working on 2 volleyball teams, so there will be a league. Coolers are not working, need to find someone to fix them. There was vandalism done to the dugout gate. If anyone has information regarding this vandalism they should contact the Mayor.

GALEN BARRETT/FIRE CHIEF reported that as of the end of April the dept. was at 116 calls. Color guard will be in the May 17<sup>th</sup> Council Bluffs parade. ROCKFORD TOWNSHIP fire/rescue contract submitted for approval. MOTION BY ANDERSON, seconded by Morgan to approve. Anderson, Jacobsen, Morgan, all ayes. Motion carried. CRESCENT TOWNSHIP fire/rescue contract submitted for approval. MOTION BY MORGAN, seconded by Anderson to approve. Anderson, Jacobsen, Morgan, all ayes. Motion carried. More members are going for advanced training so hopefully within the next couple of years the service can be up-graded.

PLANNING COMMISSION reported that addition application 1414 Golden Hills was approved. Shed application for 1901 OLH was approved. An accessory building for 104 OLH was denied as it did not conform to the ordinances.

ANDERSON reported that the weeds at the park have been sprayed. The dugout gate damaged has been fixed. There will be a FEMA meeting on 5-6-14 to discuss lagoon repairs.

MORGAN reported that there will be clean-up at the pool on Saturday from 9- noon.
