LAGOON REPAIR PAY REQUEST # 1 submitted for payment. Pay request is in the amount of \$246735.90. Advance request submitted to FEMA for 75% being \$185051.92. City share is \$61683.98. This will be paid upon FEMA \$ being received. MOTION BY HELDRETH, seconded by Beck to pay #1 pay request. Jacobsen, Hildreth, and Anderson, Beck, Morgan. Motion carried.

PARK BOARD- NO REPORT

GALEN BARRETT/FIRE CHIEF reported dept. is at 191 calls as of the end of July. Color Guard presented at Westfair. The new SCBA's have arrived and training will be August 11th. IA. West Foundation grant for \$10,000. and donation from Fire Auxillary for \$10,000. made this purchase possible.
