RESOLUTION 01242016 DEMONSTRATING LOCAL SUPPORT AND PARTICIPATION IN THE PROJECT. MOTION BY JACOBSEN, seconded by Anderson to approve Resolution 01242016. Powers, Adams, Hildreth, Jacobsen, all ayes. Motion carried. Both of these resolutions were necessary for the submitted C.I.T.I.E.S. grant. Grant awards will be announced after the 1st of the year and monies awarded by March 2017.

MINDI HIVELY/PARK BOARD reported that they are finished with the park for the year. Concession has been cleaned out, trash will be cancelled as of Nov. 1st, 2016 and maintenance can winterize everything whenever it is convenient for him.
